Please note, that this Fee Schedule only applies to those people who are joining the Association for the first time, or, those Members who are rejoining after a period, of non-membership, of longer than 24 months.

Members who have failed to renew, within the required period, must pay the \$30 Annual Fee, if they are rejoining within the financial year that they received notice for.

A \$50 Rejoining Fee will apply, if a member is rejoining in the financial year following the year of notice. Example: If, I have received a renewal notice for 90/91 and failed to renew, within the required period, I must pay a \$50 Rejoining Fee if I rejoin Financial Year 91/92.
